A letter concerning DBG funding availability and our opportunity to be considered part of an urban county was read.

There will be a meeting at the Concord Community Center on June 21<sup>st</sup> regarding preparation for the Township Association meeting with the commissioners, Linda will attend.

The Farm Bureau Policy Development meeting will be June 13 at the Fairgrounds. Rich will try to attend.

A letter was received from a Leroy resident regarding cleaning out his ditch on Callow Rd

A notice that a one year old culvert pipe on Lester Dr. is rotting out. Chuck will investigate.

## **Department Reports:**

**ZONING:** Sixteen calls were received and three permits were issued. On June 14, JJJ Properties Conditional Use Permit hearing will be held. Four inspections have been done. There are 24 still open. Seventeen violations are under investigation, one citation and four letters were mailed out. With regards to Osborne's sign on Vrooman Rd. nothing has happened. Myron will send out a letter.

**FIRE:** Twenty-two calls since last meeting. On Aug. 19<sup>th</sup> the Red Cross will hold their annual blood drive at the community center. Rich Lesak has resigned/retired from the fire dept. The association will hold a retirement party for him at DeRubertis Party Center on July 30<sup>th</sup>. Tickets are available.

**ROAD**: Mowing and ditching has begun. Men are getting prepared for the Issue II project on Jennings Dr.

**CEMETERIES**: The Eagle Scout has presented plans for the Paine Rd. Cemetery improvements. There was a nice turnout at the Memorial Day service at Vrooman Rd. Cemetery. Some errors in "unmarked" Veteran's burials were found and have been corrected in the computer program. The pump at the cemetery is not working. The Trustees need to contact some residents about all of the decorations they have placed on the graves.

**PARKS**: No report.

**OLD BUSINESS**: The County Engineer has requested a letter indicating unanimous support for the roundabout at 5-points. A motion was made by Chuck and seconded by Rich. All were in favor. A letter will be sent to the County Engineer.

A resident requested a speed study be done at 5-points on Rt. 86. Chuck made a motion/Rich seconded. Chuck & Rich were in favor, Linda voted, "not in favor".
