Each bid shall include the full and correct name and corporate status of the bidder and must be accompanied by a bid guarantee in the form of an original bid bond signed by a satisfactory corporate surety licensed to do business in the State of Ohio in favor of the Board of Leroy Township Trustees or by a certified check, cashier's check, or money order, drawn on a solvent bank or savings and loan association in the amount of five percent (5%) of the bid amount made payable to the Board of Leroy Township Board of Trustees, conditional that bidder shall, if bid is accepted, execute a contract in conformity to the Bid Documents.

Bids must be submitted in a sealed envelope marked on the outside with the bidder's name and address and: "Leroy Township Proposal for S.C.B.A".

All bids, whether delivered or mailed, must be received on or before 8:00 p.m. local time on Monday, February 2, 2015.

No bidder shall be considered the lowest and best bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply, if the bidder is listed on the Auditor of State's Database as having a "Finding of Recovery" as that term is defined in R.C. 9.24. No bidder shall be considered the lowest and best bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply unless the bidder has completed a certification that the bidder is in compliance with R.C. 3517.13. A copy of the certification is included with the instructions to bidders and must be submitted with the bid.

The Board of Leroy Township Trustees reserves the right to reject any and all bids and waive technicalities in any bids and to award the contract to the lowest and best bidder.
