

LEROY TOWNSHIP TRUSTEE MEETING

The Leroy Township Trustees met in regular session on Monday, May 18, at 7 p.m., at the Leroy Township Hall.

**ZONING:** Myron reported 16 calls and two permits issued since the last meeting. There were no requests for variances or conditional use permits. There are twenty open inspections and forty-one possible reported illegal businesses. There are eleven new junk vehicle violations Myron is checking on. Myron stated he met this morning with the County Prosecutor regarding the barn on Brakeman Road and all of the junk which is on the property. Myron and the Prosecutor are reviewing all of the facts they have gathered. Myron also tried to contact the resident Mr. Mahro, but no one came to the door. Don Crellin stated he will be attending the zoning workshop in Youngstown through the Lake County Planning Commission. Myron and Dennis Keeney would also like to go. The cost is \$60.00 per person. Don goes through the Lake County Planning Commission. Heather made a motion to pay \$120.00 for Myron and Dennis, plus mileage to attend the zoning workshop in Youngstown, 2<sup>nd</sup> by Chuck, all were in favor.

**FIRE:** The Fire Chief was working. Rich Sr. read his report. There were 24 calls since the last meeting, year to date 263.

**NEW BUSINESS:** Heather stated Mike Murphy should be able to get started on the floor replacement and painting of the community room in about two weeks. The County Engineers have an on line site where you can view the construction of the new Vrooman Rd. bridge via a web cam they have installed. The temporary one-way bridge over Grand River on Vrooman Rd., should be open June 15<sup>th</sup>.
