Department Reports:

ZONING: Myron reported 221 calls total for the year, 19 permits issued, which includes3 new homes. No applications for variances or conditional use permits. Nineteen inspections were completed, and 17 remain open. Myron identified 21 new zoning violations and closed 11 of them. Eight of the 21 are businesses. Two affidavits filed are still open, that being Osbornes building and sign on Vrooman Rd. just North of I-90 entrance. A scheduled hearing on the 29th of December was a no show on Osbornes behalf. There is another scheduled for Jan. 5th. This is for both of Osborne's violations, if there is a no show on his behalf this time, a warrant will be issued.

ROAD: Chuck reported a little salt put down, one area ditched, and one culvert pipe installed. Plans for next year will be Chadwick Rd., dust control, same as Seeley Rd. in 2015. Contemplating applying for Issue II for front end of Mildon Dr.
