

# *LEROY TOWNSHIP TRUSTEE MEETING MINUTES*

The Leroy Township Trustees met in regular session on Monday, January 10, 2011, at 6pm at the Leroy Township Hall.

Present were: Chuck Klco, Linda Burhenne, Richard VanPelt, and Sharon Rodgers.

The purpose of this public meeting was to handle any old business needing attention, as well as new business, including approving temporary appropriations for the year 2011.

Chuck Klco opened the meeting.

**OLD BUSINESS:** Chuck made a motion to apply for the 2011 Community Residential Recycling Grant, 2<sup>nd</sup> by Linda Burhenne, all were in favor. Poll of the vote: Klco, aye, Burhenne, aye, VanPelt, aye. **Resolution 11-04**  
Due to a 20% decrease this year in grant reimbursements, Chuck made a motion to have the recyclables picked up once per week, as opposed to twice in 2010. Linda seconded the motion, all were in favor.

**NEW BUSINESS:** Linda Burhenne made a motion to appoint Anthony Falcone to the Leroy Township Zoning Board of Appeals, 2<sup>nd</sup> by Chuck, all were in favor. Linda made a motion to accept Vic Rebenock's resignation from the Board of Zoning Appeals, 2<sup>nd</sup> by Chuck, all were in favor. Linda made a motion to accept David Tycast's resignation as assistant zoning inspector, 2<sup>nd</sup> by Rich VanPelt, all were in favor.

Linda made a motion to advertise for an assistant to our Zoning Inspector, 2<sup>nd</sup> by Rich VanPelt, all were in favor. Linda made a motion to advertise for an alternate for both the Board of Zoning Appeals and the Zoning Commission Board. 2<sup>nd</sup> by Rich, all were in favor.

**FISCAL OFFICER:** At the Fiscal Officer's request, Chuck made a motion to accept the temporary appropriations **Resolution 11-02** for 2011, 2<sup>nd</sup> by Linda, all were in favor. Poll of the Board: Klco, aye, Burhenne, aye, VanPelt, aye. Chuck made a motion to approve **Resolution 11-03**, increase in the minimum wage for part-time probationary firefighters to \$7.40/hr., from \$7.30, 2<sup>nd</sup> by Rich, all were in favor. Poll of the Board: Klco, aye, Burhenne, aye, VanPelt, aye. Chuck made a motion to accept 2011 blanket purchase orders and purchase order, 2<sup>nd</sup> by Linda, all were in favor.

Chuck informed the Board that the Leroy Twp. baseball committee does not want the old tractor given to them by the road dept. Therefore, Chuck made a motion to sell the tractor starting at a minimum bid of \$2,000.00. 2<sup>nd</sup> by Rich, all were in favor.

Motion to pay all bills made by, Chuck, 2<sup>nd</sup> by Linda, all were in favor.
