Attorney, Ron Graham stated that as long as the Mahr case is in Court of Appeals we cannot collect on the fine. They are appealing it as being too severe. Once it goes back to the Judge we can start our enforcement of the fine collection.

Discussion followed regarding the Mahr farm, health department septic regulations and Allega. Myron stated only land taxes can be collected, none on the equipment because it is portable.

Charlie stated that Carter Rd. repairs is being funded by Issue II and the County and work should commence once school is out.

CEMETERIES:

PARKS: The community garage sale was a success. Several homes had garage sales, over 40 of them, and many people turned out to shop. Movie night will be July 21st.
