All trucks have had their annual pump and ladder testing done and all have passed.

### **OLD BUSINESS:**

Logan Campbell was hired on a probationary basis and has started training. Concerning the status of the Callow Rd. residence and the bridge to his house, Mike Shoff said the bridge has been approved for 90,000 lbs. Our tanker is

## 50,000, lbs. He will keep an eye on the driveway as it is being put in for access by our fire dept.

ROAD: Charlie stated the contractors for the county applied as a test a fog coat of road surface on Jodi drive. It would not hold, would not stick to our stone on the road and became a real mess. Therefore we did not have it applied on Mildon, Piney, or Shirley as planned. The guys have been doing a little ditching, some on Baker. Some patching needs done on Valentine. Chuck said he has talked to the ODOT. He is going to meet someone from ODOT to review the area between Girdled Rd. and McMillan Creek to see why it is such a high accident area. All of our summer help is gone. We are down to our two full time men only. They are getting the trucks ready for winter. Chapman Electric will do the electric panel and fans in the town hall, this is being paid for through an energy grant from NOPEC. We are applying again for Issue II District 7 small government grants for Radcliffe Rd. Between Friday to Sunday morning we received 7" of rain. Lester, & Callow roads had several culvert wash outs. Our men were working on Sunday to get them repaired.

We need to get the walkway at the town hall repaired and at the Heritage house. Chuck is going to have our road department fix them.

**CEMETERIES**: Two burials this past weekend. One on a Saturday, and a special request was done on Sunday.

**PARKS:** Annual Township Halloween party will be October 27<sup>th</sup> at 6 p.m. at Metro Park Hidden Lake. Rain-out will be held at the fire station. This Wednesday at 6:30 the group is meeting at the community room to stuff candy bags. Everyone is welcome to help. Saturday, December 1<sup>st</sup> will be breakfast with Santa.
