## **Department Reports:**

**ZONING:** Myron's report is attached. Chuck Klco inquired about the garage being built across from the school. Myron stated that he had measured it and it meets the 100-foot setback.

**FIRE:** Chief, Mike Shoff gave the report. There have been 23 calls since the last meeting. Year to date, 518. Mike had the new agreement for Central Dispatch and Communications Services to be signed by the Trustees. Fire Department Christmas party will be Dec 1 at 12 p.m. The state wants to go paperless for reporting, so they offered Leroy Fire Department a grant for two iPads. Chief Shoff will pick them up tomorrow. The spaghetti dinner was well attended.

**ROAD:** Trustee, Chuck Klco gave the report. They have been ditching, replacing signs and getting the trucks ready for winter. Sidewalks were put on hold due to the weather. The one-ton will need to be replaced in the new year with an estimated cost between 80,000 to 100,000.

**CEMETERIES**: There were discussion concerning the amount of room left and the potential clearing of land. Area behind the veterans' memorial and the replacement of unhealthy trees were discussed. Lori Watson brought a historical cemetery map to the township on Friday.
