MINUTES

The Leroy Township Trustees met in regular session on Monday, July 1, 2019, at 7 p.m. at the Leroy Township Hall.

Present were: Chuck Klco and Heather Shelton, Trustees. Sharon Rodgers, prior Fiscal Officer, Julie Himmelman, appointed Fiscal Officer, and Ron Graham, Attorney at Law.

Trustee VanPelt was haying.

Guests: None.

Heather Shelton opened the meeting with the Pledge of Allegiance.

Heather read Sharon Rodgers letter of resignation effective June 29[,] 2019. Chuck made a motion to accept Sharon's letter of resignation. Heather seconded and all were in favor.

Heather noted there was a vacancy in the office of Leroy Township Fiscal Officer. Whereas, pursuant to the O.R.C., the Trustees are to appoint a replacement to finish the vacant term which ends March 31, 2020, Heather made a motion to appoint Julie Himmelman, Fiscal Officer of Leroy Township through March 31, 2020. Chuck Klco seconded. Poll of the vote: Shelton, aye. Klco, aye.

Sharon swore Julie into office.

Minutes of the previous meeting were read and approved.

Correspondence: Chuck stated there was an anonymous letter from a resident of Callow Road complaining about the road's condition.

We received a \$750 grant from the Painesville Elks Club which we used towards the purchase of 2 personal thermal imaging cameras for the duty crew. These help us see through smoke to find victims and also aid in finding hot spots in a fire.

I have been selected to attend a class by the Ohio Fire Chiefs, "Building a Toolbox to Lead a Successful Fire Dept." The registration fee is \$50 but includes 2 days of classroom, food and lodging. I will need my request for class form signed if approved to go.

The full time firefighter written test is scheduled for August 7, 2019. There are 6 firefighters taking it. This will establish a list of candidates to hire from.

Chuck made a motion to allow Chief Mike Shoff to attend the class at Mohican Lodge. Heather seconded and all were in favor.

Road: Chuck reported that the crew is working on patching. They are currently on Taylor Road. There are two funerals this week which will take them away from patching work this week. Chuck stated that material costs are very high and the township will have to look at an additional levy.

Cemeteries: One of the two burials this week is for Cathleen Cave, our own Pocket Lady, a very active member of our community.

Parks: August 3rd will be our outdoor movie night. The kids from our baseball teams picked the movie "How to Train your Dragon". Also, we are going to have bingo prior to the movie at 6:30.
