The Lake County Planning Commission took under consideration the above-mentioned zoning text changes at their regularly scheduled meeting on Tuesday, August 31, 2021. The Lake County Planning Commission recommended the following changes to the proposed text amendments:

# <u>Leroy Township Text Amendment Sections 2 (Definitions) 19 (Swimming Pools) & 21</u> (Fences)

- Make the changes to sections 2 and 19.
- In section 21, create new Section for Fence Standards, either 21.08 or 21.02 and renumber. Move the existing second paragraph on the finished side should be facing the neighbors from Section 21.01 to the new section as subsection "A". Create a new subsection "B" called accepted fence materials and move B2 and B3 to it. Create a new subsection "C" call "Prohibited Materials" and move B1 to it.
- Correct the typographical error in 21.02
- Correct the unintended removal of 21.05 Maintenance

# Leroy Township Text Amendment Sections 16 (Rural Residential R-2) & 22 (Oil and Gas Well Regulations

Recommend making the changes as they are.

#### Leroy Township Text Amendment Sections 20 (Construction on Flag Lots) & 25 (Parking)

- Remove the language stating that flag lots are discourage and no other lot configurations are possible.
- Recommend making the changes to section 25.
