Our new fire engine delivery date has been pushed back to sometime at the end of May.


Pancake Breakfast was a success. We want to thank everyone who attended and helped out.

Heather stated May 14 is a zoning meeting and June $18^{\rm th}$ is the next Comprehensive Plan meeting.

NEW BUSINESS:

The Leroy Softball Board would like to hire Seamus Bly to drag our fields, and line them, as well as other odd jobs, within the rules and regulations of the Ohio Minor Labor Laws. Seamus is a Leroy resident, a 4-H member and plays softball.

Heather made a motion to hire Seamus at \$13.00 per hour, seasonal softball only. 2nd by Rich VanPelt, all were in favor. Resolution 24-17

Chairman, Rich VanPelt made a motion to go into executive session to discuss personnel, 2ndby Heather, all were in favor.

Rich made a motion to close the executive session and open back into public meeting, 2^{nd} by Heather, all were in favor.

Jason stated we had three applications for hire of fulltime laborer for the road dept. After interviewing all three, Jason made a motion to hire Braden Brewster as our second full time employee on the road dept. effective June 3rd at an hourly rate of \$20.00. Based on his passing of a drug and alcohol test. Jason stated our probation period is 6 mos., after that time, depending on his evaluation, we would like to send him to get his CDL, which the township will pay for.

Heather Shelton seconded the motion. Poll of the vote: VanPelt, aye, Shelton, aye, Rodgers, aye. Resolution 24-16

Jason made a motion to increase our two part-time seasonal workers who also possess a CDL, to \$21.00 per hour effective with the next pay period starting May 11, 2024. Heather seconded the motion. Poll of the vote: VanPelt, aye, Shelton, aye, Rodgers, aye. Resolution 24-17

Rich VanPelt made a motion to hire LCM Landscaping to clean up our cemeteries before Memorial Day. Jason seconded; all were in favor. They did it last year and will do it for the same cost as last year. This includes cleaning up and mulching. \$2,300.00 was paid last year.

Heather stated she will contact the contractor who demolished Leroy School and ask them to come out and fill and grade the property per the contract.

Jason noted he wanted to make a motion to purchase a new Mack Dump Truck, to replace our old one, however they did not get back to him with a quote. This will be purchased with our ARPA funds.
