NEW BUSINESS:

We would like to welcome Ozzy Vaughn. Ozzy's first day is today, and he will be replacing Ray Paduano's fulltime spot.

Assistant Chief Wilhelm will be stepping down and returning to the rank of Firefighter as of October 10. He will continue to serve our community, and we want to thank him for his years of leadership in our fire department. Craig will continue to help shape our department for he future.


